Pursuant to the provisions of the General and Business Corporation Law of Missouri, the undersigned Corporation certifies the following:

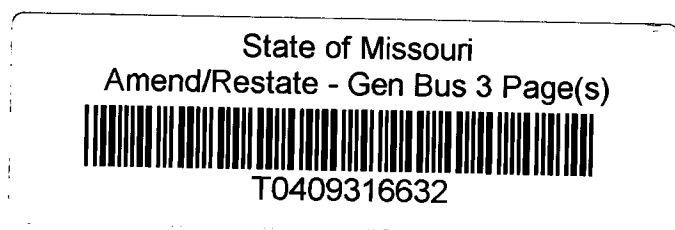
1. The present name of the Corporation is Socket Holdings Corporation

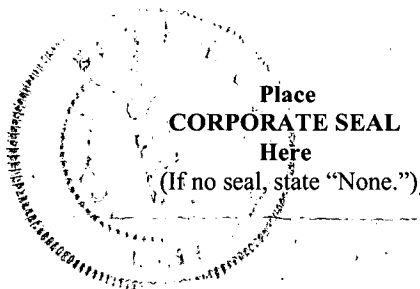

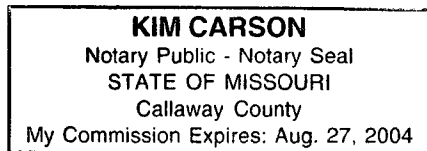

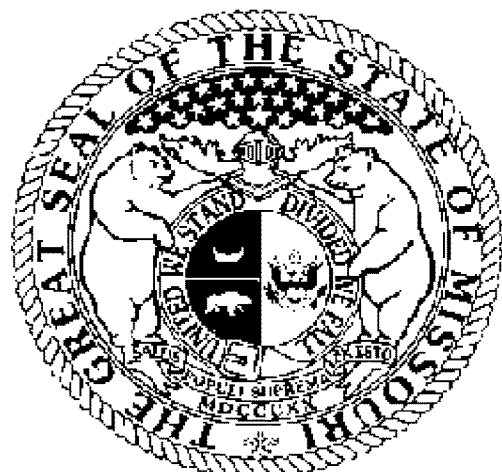
