TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT is made as of April 30, 2010, from Paul Herrera, an individual ("Assignor"), to Fight Industries, LLC, a California limited liability corporation ("Assignee").

RECITALS

A. Assignor and Assignee entered into a Compromise Agreement dated December 14, 2009 (the "Compromise Agreement"), pursuant to which Assignor agreed to assign certain trademark assets to Assignee.

B. Assignor owns all right, title and interest in and to the trademark application identified on the attached Schedule A and the associated common law rights (collectively, the "Mark").

C. Assignor wishes to assign, and Assignee wishes to acquire, all of Assignor's right, title and interest in and to the Mark, throughout the world.

AGREEMENT

Accordingly, in consideration of the promises and of the mutual covenants and conditions contained herein, and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignor hereby sells, assigns, transfers, and sets over to Assignee, its successors, assigns and legal representatives, Assignor's entire right, title and interest in and to the Mark throughout the world, together with the goodwill of the business associated with the Mark and the right to bring actions and recover for past or future infringements or other violations of the rights assigned herein; and
2. Assignor hereby further covenants that (a) Assignor has the full right to convey the interest assigned by this Trademark Assignment; (b) Assignor and its successors, assigns and legal representatives shall cooperate with Assignee, at Assignee's request, to execute all documents reasonably necessary to perfect the interests assigned hereby; and (c) Assignor has not executed and will not execute any agreement in conflict with this Assignment.
