EXHIBIT A

TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT, (the "Assignment") is made as of the 5<sup>th</sup> day of August, 2010, by and between Ghaleb Hijazi, individually, and doing business as LAMP OF LIBERTY (a/k/a *Misbah Al Hurriyya*) (hereinafter collectively "Hijazi"), at Khalid Ben Al Waleed Street, Building Number 108, P.O. Box 841110, Postal Code 1181, Amman, The Hasemite Kingdom of Jordan ("Assignor"), and Atlas Economic Research Foundation ("Atlas"), doing business at 1201 L Street, N.W., Washington, DC 20002 ("Assignee").

WHEREAS, Assignor has applied to the United States Patent and Trademark Office to register the Mark MISBAHALHURRIYYA (appearing with the design of a lit oil lamp above the Arabic text "misbahalhurriyya") in International Classes 16 (App. Ser. No. 77/750,521) and 42 (App. Ser. No. 77/750,530) (collectively, the "Applications"); and

WHEREAS, each party contends that it is the rightful owner of the Marks contained in the Applications, and Assignee has instituted opposition proceedings against the Applications in the United States Patent and Trademark Office; and,

WHEREAS, Assignor has registered two marks in Jordan (Nos. 102881 and 102882 accepted 16/10/2008) which are currently subject to cancellation proceedings in Jordan initiated by Assignee, and

WHEREAS, Assignor and Assignee desire to resolve any and all disputes related to the ownership of the Mark everywhere in the world, together with the goodwill associated therewith.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:


Assignment. Assignor hereby grants, bargains, transfers, sells, assigns, conveys and delivers to Assignee its entire right, title and interest in and to on a worldwide basis the Mark MISBAHALHURRIYYA, if any, including the Applications, and any common law rights, trade names, other pending applications, or registered MISBAHALHURRIYYA related marks in the U.S. or abroad, including the MISBAHALHURRIYYA marks (Nos. 102881 and 102882 accepted 16/10/2008) and trade names (No. 134048 issued on 26/4/2007) in Jordan, and all goodwill appurtenant therewith, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made, together with all claims for damages by reason of past,

present or future infringement or other unauthorized use of the Mark, with the right to sue for damages, and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representatives.


