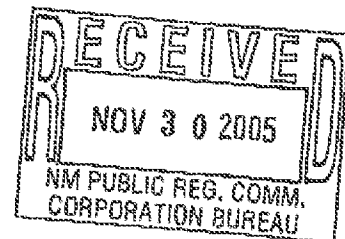
- A. The name of the Corporation is First State Bank N.M.
