**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION
OF
MILLER INSURANCE GROUP, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned for and on behalf of Miller Insurance Group, Inc. (the "Corporation"), a Florida corporation, hereby adopts the following amendment to its Articles of Incorporation.
