Assignor hereby declares that the foregoing power is coupled with an interest and as such is irrevocable.

2. Assignor hereby assigns to Assignee, all right, title and interest in the United States in and to the Registered Trademarks together with the goodwill of the business symbolized by the Registered Trademarks and registrations thereof.
