TRADEMARK ASSIGNMENT**

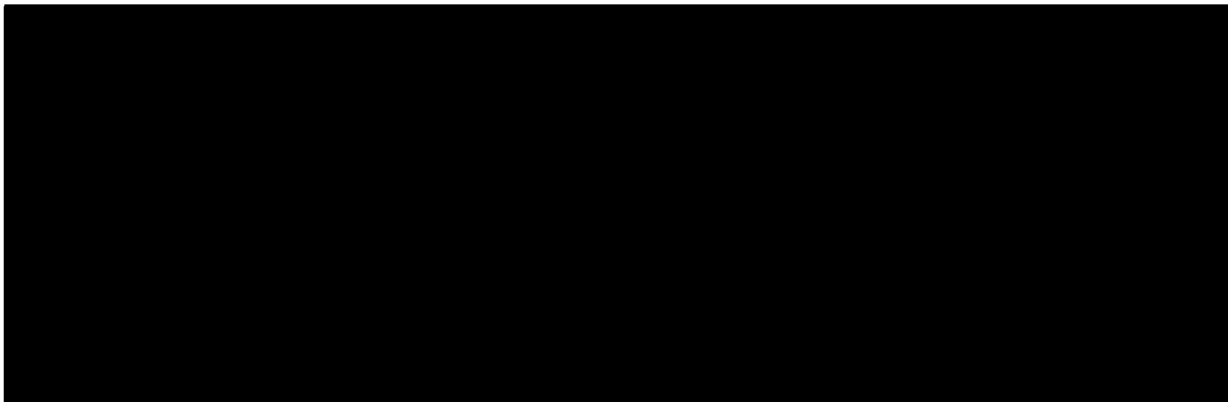

1. ASSIGNMENT:

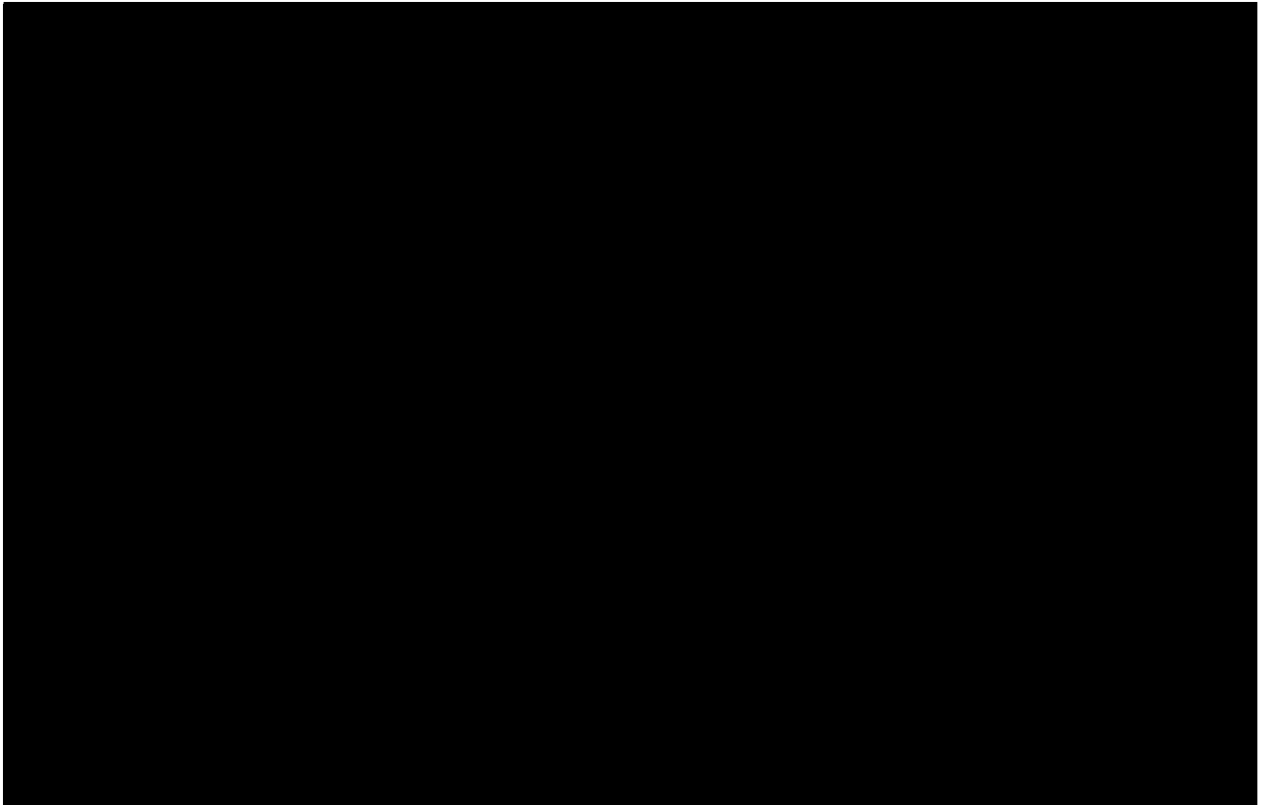

- 1.2 The right of Assignor to enforce any of the Marks against infringement thereof and keep any recovered damages or costs expires on the date of execution of this Assignment.






2. REPRESENTATIONS AND WARRANTIES:

2.1. Assignor represents and warrants to Assignee, its successors, assigns, or legal representatives that there are no encumbrances on the Marks, no licenses of any kind to any third party under the Marks are in existence, and full right to convey the Marks as herein expressed is possessed by Assignor. Encumbrances shall include, but not be limited to, mortgages, deeds of trust, liens, pledges, restrictions, covenants, liabilities, hypothecations, assignments, and security interests.
