BILL OF SALE

AMP'D MOBILE, INC., a Delaware corporation ("Seller"), for good and valuable consideration paid by, at or before the delivery of these presents, the receipt and sufficiency of which is hereby acknowledged by Seller, hereby grants, bargains, sells, conveys, assigns, and transfers to Michael Chang ("Purchaser"), all of the right, title and interest of Seller in the assets set forth on Schedule 1 of that certain Asset Purchase Agreement dated August 2, 2010, by and between Seller and Purchaser, incorporated by reference herein, free and clear of all liens and encumbrances except as set forth in such Asset Purchase Agreement (the "Assets").

Seller hereby assigns, transfers and sets over unto Purchaser, the entire right, title and interest of Seller in and to the domain names, any goodwill associated therewith and all rights to sue for, to claim and to recover for all past, present and future infringement of the domain names.

Seller authorizes and requests Network Solutions, LLC, or any other registration authority, to transfer the domain names and the registration thereof from Seller to Purchaser. To effect the transfer of all right, title, interest and goodwill in and to the domain names, Seller will cooperate in executing appropriate documents reasonably requested by Purchaser to complete formalities for perfecting the assignment and recording of the domain names. Further, Seller agrees that, upon request and without further compensation, but at the cost and expense of Purchaser, it will perform any and all lawful reasonable acts, including the execution of oaths, assignments, powers of attorney, notices, instruments and any and all other papers, as well as the giving of oral and written testimony and authorization codes, which Purchaser shall reasonably consider necessary for vesting, perfecting, recording, or maintaining the title of Purchaser to said domain names. All costs associated with the foregoing, including, but not limited to, all legalization and notarization costs, shall be borne by Purchaser.

Purchaser is purchasing the Assets in "as is" and "where is" condition.
