TRADEMARK ASSIGNMENT

This Trademark Assignment dated as of November 10, 2006 (the "Effective Date"), is by and between:

1. Colorado Catastrophe & Restoration, Inc., a Colorado corporation ("Assignor");

2. COCAT, LLC, a Delaware limited liability company ("COCAT").

WHEREAS, the Assignor and COCAT have entered into a certain Asset Purchase Agreement, executed concurrently herewith (the "Agreement"), pursuant to which Assignor is obligated to execute this Trademark Assignment;

NOW THEREFORE, for the good and valuable consideration set forth in the Agreement and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby:

1. Grant, sell, assign, transfer, and convey unto COCAT, its successors, assigns, and legal representatives, all of Assignor's right, title and interest in and to the Trademarks, including all applications, registrations, and in and to any renewals and extensions that may be granted thereon, together with the goodwill of the business connected therewith, and together with the right of Assignor to take action, claim relief, and recover damages in respect of infringements occurring prior to the date of this Assignment.

2. Covenant to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers and take any actions necessary to perfect and vest such rights, title and interest in COCAT, its successors, assigns and legal representatives. If COCAT, its successors, assigns or other legal representatives shall desire to file any continuation applications based upon any of the Trademarks, or to file a disclaimer relating thereto, Assignor will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such divisional or continuation application, or such application for extension or reissue and the procuring thereof, and for the filing of such disclaimer, without further compensation but at the expense of COCAT, its successors, assigns or other legal representatives, all as reasonably requested by COCAT.

3. This Trademark Assignment may be executed in counterparts, and when so executed, each counterpart shall be deemed an original, and said counterparts shall constitute one and the same instrument. Any attempt by any party to recover damages (or take any other action) for any breach of this Trademark Assignment shall be subject to all of the terms and conditions of the indemnification provisions set forth in Article VII of the Agreement.
