REASSIGNMENT AND RELEASE OF SECURITY INTEREST - TRADEMARKS

This Reassignment and Release of Security Interest (this "Release") is made as of October 1st, 2010 by THE BANK OF NEW YORK MELLON, a New York banking corporation, as Administrative Agent (the "Administrative Agent") in favor of VISTEON CORPORATION, a Delaware corporation (the "Company"). Capitalized terms used in this Release, but not defined herein, shall have the respective meanings ascribed to them in the Credit Agreement, Security Agreement or Trademark Security Agreement referred to below.

Recitals

WHEREAS, the Company, and certain subsidiaries of the Company, collectively as the borrowers (the "Borrowers"), JPMorgan Chase Bank, N.A., as the Administrative Agent (the "Prior Agent") and several lender parties thereto (the "Lenders"), entered into that certain Credit Agreement, dated as of August 14, 2006 (as amended or modified from time to time, the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, the Borrowers, including the Company, (i) executed and delivered a Pledge and Security Agreement, dated as of August 14, 2006, in favor of the Prior Agent (as amended or modified from time to time, the "Security Agreement"); and (ii) certain other security documents (including the Trademark Security Agreement defined below), in order for the Company and the other Loan Guarantors to induce the Lenders to enter into and extend credit to the Borrowers under the Credit Agreement and to secure certain obligations of the Borrowers that the Loan Guarantors have agreed to guarantee pursuant to Article X of the Credit Agreement (the "Secured Obligations");

WHEREAS, in connection with the Security Agreement, pursuant to a Trademark Security Agreement, dated as of August 14, 2006 (as amended or modified from time to time, the "Trademark Security Agreement"), by and between the Company and Prior Agent, the Company pledged, assigned and granted to the Prior Agent, for itself and for the ratable benefit of the Lenders, a security interest in the "Trademark Collateral" (as defined in the Trademark Security Agreement), including the trademark registrations identified on Schedule 1 to this Release;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 3495/0009 on March 7, 2007;

WHEREAS, pursuant to that certain Successor Agent Agreement, dated as of July 15, 2009 and that certain Assignment of Trademark Security Agreement by and between the Prior Agent and Administrative Agent dated as of July 15, 2009 ("Assignment of Trademark Security") the Prior Agent assigned, and the Administrative Agent assumed, the rights, powers, privileges and obligations of the Prior Agent under the Trademark Security Agreement;

WHEREAS, the Assignment of Trademark Security was recorded with the United States Patent and Trademark Office at Reel/Frame 4026/0327 on July 17, 2009;

WHEREAS, the Borrowers have paid all of their outstanding Secured Obligations to the Administrative Agent and Lenders; and

WHEREAS, the Administrative Agent and Lenders wish to reassign to Company and release all interest that Administrative Agent and Lenders may have in the Trademark Collateral.

Agreement


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Lenders, hereby terminates, releases and discharges any and all security interest in the Trademark Collateral and reassigns to Company, without recourse, representation or warranty, all interest of Administrative Agent and the Lenders in the Trademark Collateral.

The Administrative Agent, at the sole cost and expense of the Company, shall take all further actions reasonably requested by the Company or its legal representatives (including, without limitation, the execution and delivery of any and all documents or other instruments) to more fully and effectively effectuate the purposes of this Release.
