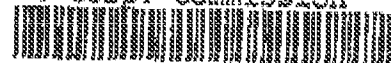

FIRST AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF

This First Amendment to Articles of Incorporation ("First Amendment") is filed with the Arizona Corporation Commission by O.E.M. SURPLUS, INC., an Arizona corporation (the "Corporation"), pursuant to A.R.S. §§ 10-1001 and 10-1003.

1. The name of the Corporation is O.E.M. SURPLUS, INC.
2. Article 1 of the Articles of Incorporation of the Corporation is hereby deleted and the following Article substituted therefor:

ARTICLE I  
NAME

The name of the Corporation shall be OEM Group, Inc.

3. Except as provided above, all other articles shall remain unchanged.
4. The foregoing First Amendment was adopted by the Board of Directors by unanimous written consent, without a meeting, pursuant to A.R.S. § 10-821, and was approved and adopted by the Shareholders by unanimous written consent, without a meeting, pursuant to A.R.S. § 10-704. 12,820 shares of common stock were issued, outstanding and entitled to vote regarding this First Amendment. 12,820 shares of common stock were voted in favor of adopting this First Amendment. No shares were voted against such First Amendment.

IN WITNESS WHEREOF, the foregoing First Amendment to the Articles of Incorporation of O.E.M. SURPLUS, INC. is hereby executed and effective August 15, 2008.
