TRADEMARK AND DOMAIN NAME ASSIGNMENT

WHEREAS, Ed Tobergte Associates Company (sometimes dba Ed Tobergte Associates, Inc. and Gear 2000), an Ohio corporation, having its principal place of business at 13 Fern Court, Hilton Head Island, SC 29928, or its designee in the case of certain domain name registrations ("Assignor"), is the owner of the trademarks, trade names, trademark registrations and applications and domain name registrations described in Exhibit A attached hereto (collectively the "Marks"); and

NOW THEREFORE, for the consideration set forth in the Principal Agreement, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, transfers, assigns and sets over unto Assignee, its successors and assigns, all right, title and interest in and to the Marks, together with the goodwill associated therewith and symbolized by the Marks, all common law rights related thereto, all registrations and applications therefor, and the rights of registration, renewal and extension, the same and the rights of Assignor to be held and enjoyed by Assignee for its own use, and for the use and enjoyment of its successors, assigns or other legal representatives as fully and entirely as if the same would have been held and enjoyed by the Assignor if this Assignment and sale had not been made; together with all claims for and damages by reason of past infringement of the Marks, with the right to sue for and collect the same for its own use and benefit, and for the use and on behalf of its successors, assigns or other legal representatives.

Assignor agrees to execute and deliver at the request of Assignee all papers, instruments, and assignments, and to perform any other reasonable acts Assignee may request in order to vest all of the right, title, and interest in and to the Marks in Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.
