TRADEMARK ASSIGNMENT

Background

A. Catholic Order of Foresters, an Illinois not-for-profit corporation, located and doing business at 355 Shuman Boulevard, Naperville, Illinois, USA ("Assignor") is the owner of the trademark FORESTER LIFE (the "Mark"), the common law rights in and to the Mark and registration No. 2,219,467 (the "Registration") for the Mark.

B. Independent Order of Foresters, a fraternal benefit society organized under the laws of Canada, having a place of business at 789 Don Mills Road, Toronto, Ontario, Canada ("Assignee"), desires to acquire all right, title and interest in and to the Mark, the Registration, and all goodwill and common law rights associated therewith, and Assignor desires to assign the same to Assignee.

Assignment

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign and transfer to Assignee all right, title and interest in and to the Mark, the Registration, and the goodwill and common law rights appurtenant thereto, and Assignee hereby accepts this assignment.

Assignor agrees to execute all instruments and documents and do such additional acts as Assignee may reasonably deem necessary or desirable to effect, evidence, record and perfect the sale, transfer, assignment and recordation of the rights being assigned hereunder.
