ASSIGNMENT OF TRADEMARK AND DOMAIN NAME RIGHTS

Subject to the terms of the General Assignment, the Assignor hereby conveys, transfers and assigns to the Assignee, and the Assignee hereby receives, acquires and accepts, all of the Assignor's right, title and interest in and to the Trademarks and the use thereof, the registration of such Trademarks, as set forth in Schedule A, all past, present and future applications and registrations therefor and extensions and renewals thereof, together with all of the business associated with the Trademarks and all of the goodwill associated with or symbolized by the Trademarks, the right to sue for past, present and future infringement of the Trademarks and the right to any other claim arising out of or relating to the use and ownership of the Trademarks, including the right to collect all proceeds and damages therefrom, and all rights corresponding with the foregoing throughout the world. Assignor hereby authorizes and requests the Commissioner for Trademarks of the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable state government or foreign countries, to record Assignee as the assignee and owner of the Trademarks registered in the corresponding jurisdiction. Further, subject to the terms of the General Assignment, the Assignor hereby conveys, transfers and assigns to the Assignee, and the Assignee hereby receives, acquires and accepts, all of the Assignor's right, title and interest in and to the Domain Names, as set forth in Schedule B, and all claims for damages by reason of past, present or future infringement or other unauthorized use of the Domain Names, including the right to collect all proceeds and damages therefrom.

- 2. <u>Further Assurances</u>. Without further consideration, the Assignor agrees to execute and deliver all such further transfers, assignments, conveyances and assurances as may reasonably be requested by the Assignee to obtain the full benefit of this Assignment, including, without limitation, in connection with the recording of this Assignment in the United States and any non-U.S. jurisdiction.
- 3. <u>Successors and Assigns</u>. This Assignment and all of the provisions hereof shall be binding upon and inure to the benefit of the parties and their respective successors and permitted assigns.
- 4. <u>Governing Law</u>. This Assignment shall be governed by and construed in accordance with the laws of the State of California (regardless of the laws that might otherwise govern under applicable California conflict of laws principles).
- 5. <u>Counterparts</u>. This Assignment may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Assignment and all of which, when taken together, will be deemed to constitute one and the same agreement.
