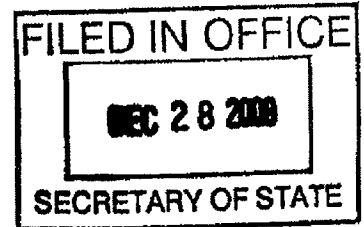

THIRD: The agreement and plan of merger has been approved and executed by each of the business entities which are to merge.

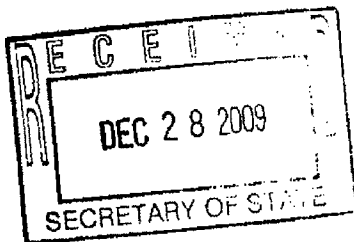

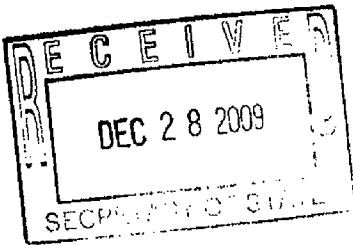
