ASSIGNMENT OF INTELLECTUAL PROPERTY

This **ASSIGNMENT OF INTELLECTUAL PROPERTY** (this "Assignment") is made as of the 2nd day of November 2010, by and among **M & Q PLASTIC PRODUCTS**, a New Jersey corporation with an address at 1120 Welsh Road, Suite 170, North Wales, PA 19454 ("Products"), and **M & Q PACKAGING CORP.**, a Pennsylvania Corporation with an address at 1120 Welsh Road, Suite 170, North Wales, PA 19454 ("Packaging") (Products and Packaging are hereinafter collectively, "Assignor"), in favor of **M & Q IP LEASING, INC.**, a Delaware corporation with an address at 1105 N. Market Street, Suite 1300, Wilmington, DE 19801 ("Assignee").

BACKGROUND

A. Assignor has various trademarks, service marks, patents and other similar items as set forth on Exhibit A (issued patents), Exhibit B (pending patent applications), and Exhibit C (registered trademarks) hereinafter the "Intellectual Property".

B. By this Assignment, Assignor desires to sell, assign, transfer, grant and convey to Assignee, and Assignee desires to take and accept the sale, assignment, transfer, grant and conveyance from Assignor, of all of Assignor's right, title and interest in, to and/or under the Intellectual Property.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignment and Assumption. Assignor hereby agrees to and does assign, transfer, grant and convey to Assignee, and Assignee hereby takes and accepts the assignment, transfer, grant and conveyance by Assignor of, all right, title and interest in, to and/or under the Intellectual Property, as well as all royalties, license fees and such other rights as are necessary and desirable for the development, production, distribution and exploitation of the Intellectual Property, together with all of the applications, registrations and goodwill associated therewith and/or which is symbolized thereby, including, without limitation, the rights to sue for infringement of the Intellectual Property, whether arising prior to and/or subsequent to the date of this Assignment, and any and all registrations, applications, filings relating thereto and all renewals and extensions thereof that may hereafter be secured under any laws now and/or hereafter in effect in any of the United States, in the United States and/or in any other jurisdiction, the same to be held, owned and enjoyed by Assignee from and after the date hereof as fully, completely and entirely as the same has been, is and/or would have been held and enjoyed by Assignor had this Assignment not been made (collectively, the "Intellectual Property Rights").



3. Binding Effect. This Assignment is and shall be binding upon Assignor, Assignee and their respective successors and assigns.




