BILL OF SALE

In consideration of the sum of \$235,000.00, receipt of which is hereby acknowledged, M&I Business Credit, LLC ("Seller") does hereby grant, bargain, sell and transfer to Outdoors Insight Inc., its successors and assigns (collectively "Buyer"), all of its right, title and interest, to the personal property described in Exhibits A, B and C annexed hereto (the "Personal Property").

THE SELLER MAKES NO WARRANTY OF QUALITY, QUANTITY, CONDITION, VALUE, LOCATION OR MERCHANTABILITY IN RESPECT TO THE PERSONAL PROPERTY AND THE PERSONAL PROPERTY IS SOLD IN AN "AS IS, WHERE IS" CONDITION, WITH ALL FAULTS. BY ACCEPTANCE OF DELIVERY OF THE PROPERTY, THE BUYER AFFIRMS THAT IT HAS NOT RELIED ON THE SELLER'S SKILL OR JUDGMENT TO SELECT OR FURNISH THE PERSONAL PROPERTY FOR ANY PARTICULAR PURPOSE, AND THAT THE SELLER MAKES NO WARRANTY THAT THE PERSONAL PROPERTY IS MERCHANTABILITY OR FIT FOR ANY PARTICULAR PURPOSE AND THAT THERE ARE NO REPRESENTATIONS OR WARRANTIES, EXPRESSED, IMPLIED OR STATUTORY, THAT EXTEND BEYOND THE DESCRIPTION OF THE PERSONAL PROPERTY ABOVE SET FORTH.

This is a final and exclusive expression of the agreement of the Seller and the Buyer and no course of dealing or usage of trade or course of performance shall be relevant to explain or supplement any term expressed in this agreement.

By acceptance of delivery of the Personal Property, the Buyer acknowledges that the Buyer has either examined the Personal Property as fully as desired, or has been given the opportunity for such examination and has refused to make such examination and assumes all risk of loss with respect to the Personal Property.
