**CERTIFICATE OF AMENDMENT  
OF THE  
CERTIFICATE OF INCORPORATION  
OF

**Under Section 805 of the Business Corporation Law**

The undersigned, William R. Gilman, being the President of Qioptiq Linos, Inc., does hereby certify:

1. The name of the corporation is Qioptiq Linos, Inc. (hereinafter called "Corporation"). The Corporation was originally formed under the name of Amarel Precision Instruments, Inc.
2. The Certificate of Incorporation was filed by the New York Department of State on October 16, 1980.
3. The Certificate of Incorporation is hereby amended to change the name of the Corporation to Qioptiq, Inc. The amendment is effected by amending paragraph 1 of the the Certificate of Incorporation to read in its entirety as follows:

"1. The name of the Corporation is Qioptiq, Inc."
4. The manner in which the above Amendment to the Certificate of Incorporation was authorized was by unanimous written consent of the directors and shareholder of the Corporation.
