RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("**Release**") is dated as of September 30, 2010 by Bank of America, N.A. ("**Assignor**"), as Administrative Agent for the Secured Parties (as defined in the Credit Agreement referred to below), in favor of the Persons listed on the signature page hereof ("**Assignee**").

WHEREAS, Ames True Temper, Inc., a Delaware corporation ("**Borrower Agent**") and certain of its subsidiaries (collectively, the "**Borrowers**"), entered into a Credit Agreement, dated as of June 28, 2004 (as amended, amended and restated, supplemented or otherwise modified from time to time, with ATT Holding Co., a Delaware corporation, as Guarantor, Bank of America, N.A., as Administrative Agent and the Lenders party thereto; and an Amended and Restated Credit Agreement dated April 7, 2006 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**") with ATT Holding Co, a Delaware corporation as Guarantor, Bank of America, N.A. as Administrative Agent, Swing Line Lender and L/C Issuer, the other Agents party thereto and the Lenders from time to time party thereto. Terms defined in the Credit Agreement and not otherwise defined herein are used herein as defined in the Credit Agreement.

WHEREAS, as a condition precedent to the making of Loans by the Lenders and the issuance of Letters of Credit by the L/C Issuer under the Credit Agreement and the entry into Secured Hedge Agreements by the Hedge Banks from time to time, each Assignee executed and delivered that certain Security Agreement dated June 28, 2004 and that certain Amended and Restated Security Agreement dated April 7, 2006, made by the Assignee to the Collateral Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Security Agreement**").

WHEREAS, under the terms of the Security Agreement, each Assignee granted and/or continued to grant, as applicable, to Assignor for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of Assignee, and Assignee agreed on condition thereof to execute that certain Intellectual Property Security Agreement dated June 28, 2004 and that certain Amended and Restated Intellectual Property Security Agreement dated April 7, 2006, between the Assignor and Assignee for recording such security interest with the United States Patent and Trademark Office, the United States Copyright Office and other governmental authorities, and such agreements were recorded under the Reel/Frame numbers (017006/0935), (017575/0397), (3227/0321) and (3303/0798), and at Volume V3537 and Document Number 497, respectively. ("**IP Security Agreement**").

WHEREAS, pursuant to the Security Agreement and the IP Security Agreement, a lien was secured on certain intellectual property of Assignee, including the following (the "**Collateral**"):

(i) the patents and patent applications set forth in Schedule A hereto (the "*Patents*");

(ii) the trademark and service mark registrations and applications set forth in Schedule B hereto, together with the goodwill symbolized thereby (the "*Trademarks*");

(iii) all copyrights, whether registered or unregistered, now owned or hereafter acquired by such Grantor, including, without limitation, the copyright registrations and applications and exclusive copyright licenses set forth in Schedule C hereto (the "*Copyrights*");

(iv) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;

(v) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

(vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing.

WHEREAS, Assignor and Assignee desire that Assignor terminates and releases its security interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby terminates, releases and discharges fully its lien on, and security interest in and to, all of the right, title and interest of the Assignee in, to and under the Collateral, including but not limited to the Patents, Trademarks and Copyrights listed on Schedules A, B, and C, respectively, and reassigns and transfers any and all interest that Assignor may have in the Collateral to Assignee.

Assignor hereby authorizes Assignee or Assignee's authorized representative to (i) record this Release with the United States Patent and Trademark Office and the United States Copyright Office, (ii) file UCC Financing Statement Amendments with the applicable filing office in order to memorialize the release of any security interest of Assignor in the Collateral, and/or (iii) otherwise record or file this Release in the applicable governmental office or agency.

Assignor further agrees to execute and deliver to Assignee any and all further documents and instruments, and do any and all further acts which Assignee (or its

agents or designees) reasonably request (at Assignee's sole cost and expense) in order to confirm this Release and Assignee's right, title, and interest in or to the Collateral.
