**WITNESSETH:**


WHEREAS, Assignor is the owner of the service marks, trademarks, and the related trade dress listed on Schedule A hereto (collectively, the "IP"); and

- b) the right to sue and collect damages for past infringement of service marks, trademarks, and the related trade dress;


