TRADEMARK ASSIGNMENT

This Trademark Assignment Agreement is made this 21 day of June, 2009 to memorialize and confirm an assignment of certain trademarks which took place and was effective June 22, 2001.

This Trademark Assignment Agreement is by and between IMI Amal Limited., a limited liability company incorporated in England and Wales, (also identified as "Amal Limited") with a business address of Holdford Road, Witton, Birmingham B6 7ES, and formerly known as Amal Limited prior to the company's name change on December 20, 1983 (hereinafter "Assignor"), and Safety Systems UK Ltd., a company incorporated under the laws of England, with a business address of Victoria Road, Leeds, LS11 5UG (hereinafter "Assignee"); and

WHEREAS, the Assignor adopted and used the "AMAL" trademarks set forth at the attached Schedule A, and was the owner of those trademark registrations and applications listed in Schedule A, prior to June 22, 2001 (hereinafter collectively referred to as the "Trademarks"); and

WHEREAS, on June 22, 2001, Safety Systems UK Ltd. (through its predecessors in interest) purchased IMI Amal Limited, with the Trademarks, including the applications, registrations, and all unregistered AMAL trademarks and service marks of IMI Amal Limited; and

WHEREAS, effective June 22, 2001, Assignee became the owner of the trademarks set forth at Schedule A;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor confirms that it assigned and now memorializes the assignment to Assignee all of its rights, title and interest in the Trademarks, including all common law rights, and trademark registrations and pending applications therefore listed in Schedule A attached hereto, together with the good will of the business symbolized by the Trademarks, and the right to sue for past infringement, held and enjoyed by Assignee as fully and entirely as it would have been held and enjoyed by Assignor if the sale of IMI Amal Limited and assignment of its intellectual property had not been made.

Assignor further agrees that it will continue, upon Assignee's request, to execute and deliver to Assignee or its legal representative any and all paper or instruments to maintain and enforce the Trademarks which may be necessary or desirable to carry out the purpose of the June 22, 2001 sale and transfer of IMI Amal Limited, including but not limited to the Trademarks, and any other documents pertaining to the transfer of the Trademarks.

Assignor further agrees that Assignee has been entitled to use, register, license and transfer any and all of the Trademarks set forth at Schedule A, and any other trademark incorporating the term "AMAL" in all territories throughout the world. Assignee shall bear all costs and fees associated with the preparation, filing and execution of any papers or documents related to the assignment of the Trademarks set forth in Schedule A, including confirmation of the assignment of the Trademarks, recordation of ownership, or maintenance of the trademarks. Assignor and Assignee acknowledge that certain other AMAL Trademarks, worldwide, including some listed on Schedule A, are or may still be registered in the name of Amal Limited (Assignor's former name), and Assignor shall use all reasonable endeavors to assist Assignee in updating the name of Assignor prior to or simultaneously with recording the assignment of the AMAL Trademarks into the name of Assignee. To that end, attached at Schedule B is a certified copy of the Change of Name certificate.

This confirmatory assignment is effective nunc pro tunc (made now to memorialize what was previously done but not recorded in writing through inadvertence or mistake) as of June 22, 2001.
