

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which hereby acknowledged, ASSIGNOR hereby confirms its assignment and sale to ASSIGNEE all rights, title and interest as ASSIGNOR may possess in and to the Trademarks in U.S. together with the goodwill symbolized by said Trademarks, concurrent with the transfer of certain tangible assets as indicia of said goodwill.


