ASSIGNMENT OF TRADEMARKS

WHEREAS, WALTER COKE, INC., f/k/a Sloss Industries Corporation, a Delaware corporation having a place of business at 4200 F. L Shuttlesworth Drive, Birmingham, AL 35207 (hereinafter referred to as "ASSIGNOR"), is the owner of the trademarks, including but not limited to all common law rights and goodwill therein, and record owner of the United States trademark registrations set forth in the SCHEDULE attached hereto and made a part hereof (hereinafter referred to as the "TRADEMARK(S)"); and

WHEREAS, UNITED STATES MINERAL PRODUCTS COMPANY d/b/a ISOLATEK INTERNATIONAL, a Delaware corporation having a place of business at 41 Furnace Street, Stanhope, NJ 07874, (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring all of the right, title and interest of ASSIGNOR in, to and under the TRADEMARKS, together with the goodwill of the business associated with the TRADEMARKS; and

NOW THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, ASSIGNOR hereby transfers and assigns to ASSIGNEE the entire right, title and interest of ASSIGNOR in and to the TRADEMARKS together with the goodwill of the business associated with the TRADEMARKS; and

ASSIGNOR, does hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARKS, the right to sue for and collect the same for its own use and

enjoyment and for the use and enjoyment of its successors, assigns and other legal representatives; and

ASSIGNOR represents to ASSIGNEE that there is not, nor never has been, any proceedings of any kind regarding the validity or infringement of the TRADEMARKS. At ASSIGNOR's option, and provided ASSIGNEE gives reasonably prompt notice of such proceedings to ASSIGNOR, either (a) ASSIGNOR will indemnify ASSIGNEE to the extent of such proceedings; or (b) ASSIGNOR will, for itself and on behalf of ASSIGNEE, defend such proceedings at ASSIGNOR's expense. ASSIGNEE's remedy hereunder shall be limited to the cumulative amount of Fifty Thousand Dollars (\$50,000.00).

ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARKS and registrations herein assigned.
