## RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

**THIS RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS** (this “**Release**”) is made as of December 17, 2010, by Bank of America, N.A. (in such capacity, “**Administrative Agent**”), for itself and the other lenders (collectively, “**Lenders**”) from time to time parties to the Credit Agreement referred to below. Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in such Credit Agreement.

### WITNESSETH:

**WHEREAS**, reference is made to the Revolving Credit Agreement, dated as of June 15, 2006, among Green Mountain Coffee Roasters, Inc., a Delaware corporation (“**GMCR**”), Subsidiaries of GMCR, the Lenders, the Administrative Agent and the other parties named therein (as amended, amended and restated, supplemented, or otherwise modified, the “**Original Credit Agreement**”), which was amended and restated (the “**Restatement**”) by that certain Amended and Restated Revolving Credit Agreement, dated as of December 3, 2007, among GMCR, Subsidiaries of GMCR, the Lenders, Administrative Agent and the other parties names therein (as amended, amended and restated, supplemented, or otherwise modified, the “**Credit Agreement**”);

**WHEREAS**, reference is also made to that certain Omnibus Amendment, dated as of December 3, 2007, among GMCR, Keurig, Incorporated as a Guarantor, and Administrative Agent, on behalf of itself and the Lenders (the “**Omnibus Amendment**”), which was entered into in connection with the Restatement, and pursuant to which the parties thereto amended the each of the Collateral Documents, including the Patent and Trademark Security Agreement, so that each of the Collateral Documents would secure the Credit Agreement.

**WHEREAS**, pursuant to the Original Credit Agreement and Omnibus Amendment, each of the entities listed on Schedule 1 hereto (collectively, the “**Granting Parties**”) granted a security interest to the Administrative Agent for the benefit of the Lenders in certain patent and trademark registrations and patent and trademark applications owned by each of GMCR and Keurig, Incorporated, a Delaware Corporation, (collectively, the “**Released Parties**”), including the patent and trademark registrations and patent and trademark applications set forth on Schedule 2 (the “**Patent & Trademark Collateral**”);

**WHEREAS**, pursuant to the payoff letter, dated as of December 17, 2010, from the Administrative Agent to GMCR, the Administrative Agent released any security interest granted by the Granting Parties in the Patent and Trademark Collateral;

**NOW THEREFORE**, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, cancels, re-pledges, reassigns to the applicable Granting Parties and releases any and all security interest it has against the Patent and Trademark Collateral, without any representation, warranty, or recourse of any kind.

If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Patent and Trademark Collateral, it hereby assigns and transfers such right, title or interest to the applicable Granting Parties, without any representation, warranty, or recourse of any kind.

At the Released Parties’ sole cost and expense, the Administrative Agent shall take any and all reasonably required further actions, and provide to the Released Parties and its successors, assigns,

designees or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments, which are in form and substance satisfactory to Administrative Agent), reasonably requested by the Released Parties to more fully and effectively effectuate the purposes of this Release.
