U.S. TRADEMARK ASSIGNMENT

ASSIGNEE shall be substituted for EMOC in all matters involving the Mark and shall hold and enjoy all of EMOC's rights with regard to the Mark as fully and entirely as said interest could have been held and enjoyed by EMOC had this assignment, transfer and conveyance not been made.


