## SCHEDULE 1

### DEED OF ASSIGNMENT

THIS DEED is dated the 9th day of February 2011.

#### PARTIES

- (1) **JOSH ANON** whose registered address is at Apartment 6, 2145, Donald Drive, Moraga, California 94556 ("**JA**").
- (2) **T2 LABS INC** incorporated and registered in the State of Delaware whose registered office is at 2711 Centreville Road, Suite 400, City of Wilmington, County of New Castle, Delaware 19808 ("**T2**").

#### BACKGROUND

- (A) JA is the proprietor of the Trademarks (as defined below).
- (B) JA has agreed to assign the Trademarks to the T2 on the terms set out in this assignment.

#### 1. INTERPRETATION

"**Trademarks**" means the registered Trademark together with any unregistered Trademark rights attached thereto short particulars of which are set out in Schedule 1.


#### 2. ASSIGNMENT

  - (a) all statutory and common law rights attaching to the Trademarks, together with the goodwill of the business relating to the goods or services in respect of which the Trademarks are registered or used; and
  - (b) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership, of any of the Trademarks whether occurring before, on or after the date of this assignment.
- 2.2 This Deed may be executed in any number of counterparts, each of which when executed and delivered shall constitute an original of this Deed, but all the counterparts shall together constitute the same Deed.
- 2.3 This Deed and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the laws of California.


