**RELEASE OF SECURITY INTEREST IN PATENTS,
PATENT APPLICATIONS, AND REGISTERED TRADEMARKS**

WHEREAS, Nalco Company, a Delaware Corporation ("Borrower"), granted a Security Interest in certain Patents, Trademarks, and other intellectual property in favor of Citicorp North America, Inc., as Collateral Agent ("Agent") for the benefit of Secured Parties identified in the U.S. Guarantee and Collateral Agreement dated and effective as of November 4, 2003, among Nalco Holdings LLC, Borrower each Domestic Subsidiary of Holdings identified therein and Collateral Agent (as amended, supplemented or otherwise modified from time to time, the "U.S. Guarantee and Collateral Agreement"), which was entered into pursuant to the Credit Agreement, dated as of November 4, 2003, among Nalco Holdings LLC, the Borrower, the Lenders and certain other parties identified therein (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement").

WHEREAS, pursuant to the U.S. Guarantee and Collateral Agreement, Borrower granted to the Collateral Agent for the benefit of the Secured Parties a security interest in all right, title, and interest to all Intellectual Property then owned or thereafter acquired, which security interests were recorded with the United States Patent and Trademark Office (the "USPTO") for patents and patent applications at Reel 014805/Frame 0132; dated as of November 4, 2003; and recorded with the USPTO on December 8, 2003, and for trademarks and trademark applications at Reel 2883/Frame 0231; dated as of November 4, 2003, and recorded with the USPTO on December 12, 2003;

WHEREAS, pursuant to the Credit Agreement and the U.S. Guarantee and Collateral Agreement, the Borrower has the right to dispose of certain Pledged Collateral;

WHEREAS, Borrower and Chemetall Corporation, a Delaware Corporation ("Assignee") entered into an Asset Purchase Agreement ("APA") dated July 24, 2008, whereby Nalco Company transferred and assigned certain assets of its Finishing Technologies Group;

WHEREAS, capitalized terms used but not defined herein shall have the meaning set forth in the Credit Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the security interest in the United States patents, patent applications, and trademarks listed in Schedule 1 hereto, under 6.05(h) of the Credit Agreement, is hereby released and discharged in all respects and, where applicable, any notices of security interest recorded with the USPTO shall be designated as released.
