WHEREAS, Assignor desires to assign, and Assignee intends to accept, the Intellectual Property, pursuant to the terms of this Assignment.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

2. This Assignment shall be binding upon, and shall inure to the benefit of, the respective parties hereto and their respective successors and assigns.
3. This Assignment may be executed by one or all of the parties in several counterparts and all such counterparts so executed shall together be deemed to constitute one final agreement as if signed by all parties, and each such counterpart shall be deemed to be an original.

5. This Assignment shall be governed by and construed and interpreted in accordance with the substantive laws of the State of Texas.


