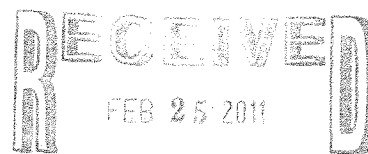

The Company may not directly acquire more than 40% in more than two companies operating in the same industrial, commercial or non-commercial area in Lebanon, in the event such acquisition aims at the institution of a legally unauthorized monopoly. This restriction does not apply to investments made outside Lebanon.

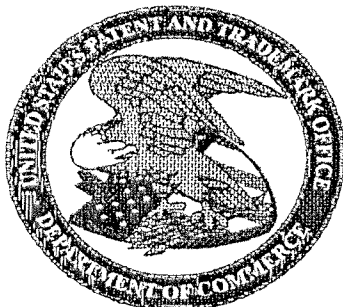
