TRADEMARK ASSIGNMENT

This Trademark Assignment effective as of Feb 1, 2011, by Babasket, Inc., a New Jersey corporation with a place of business at 89 New Bridge Road, Bergenfield, N.J. 07621 ("Assignor"), in favor of Build-A-Bear Retail Management, Inc., a Delaware corporation with a place of business at 1954 Innerbelt Business Center Drive, St. Louis, Missouri 63114 ("Assignee").

WITNESSETH:

WHEREAS, Assignor is the owner of all worldwide right, title and interest in and to the mark BUILD-A-BASKET used in connection with retail store services featuring custom designed gift baskets and gifts and accessories (the "Mark"), the goodwill developed through the use of the Mark and the United States Trademark Application Serial No. 76/530,408.

WHEREAS, Assignee is desirous of acquiring all rights to the Mark.


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties, intending to be legally bound hereby, agree as follows:

1. Assignor hereby irrevocably assigns and transfers to Assignee all worldwide rights, title, and interest in and to the Mark and all goodwill associated therewith and all associated rights therein including all existing and future trademark rights therein, all rights to apply for and receive trademark registrations based on said Mark, together with all rights of action accrued, accruing and to accrue under and by virtue hereof, including the rights to sue and to receive all damages, payments, costs, and fees associated therewith.

2. Upon the request and at the expense of the Assignee, Assignor shall execute and deliver any and all instruments and documents and take such other actions as may be necessary or reasonably requested by Assignee to document the aforesaid assignment and transfer or to enable Assignee to secure, register, maintain, enforce and otherwise fully protect its rights in and to the Assigned Trademark.
