CERTIFICATE OF INCORPORATION OF  
KUDZU INTERACTIVE, INC.

Kudzu Interactive, Inc., (the "Corporation") organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:

**FIRST:** The name of the Corporation is "Kudzu Interactive, Inc."

**SECOND:** The date of filing of the original Certificate of Incorporation of this corporation with the Secretary of State of the State of Delaware was February 9, 2007. A Corrected Amended and Restated Certificate of Incorporation of this Corporation was filed with the Secretary of State of the State of Delaware on March 20, 2007. A Second Amended and Restated Certificate of Incorporation of this Corporation was filed with the Secretary of State of the State of Delaware on January 27, 2010. A Third Amended and Restated Certificate of Incorporation of this Corporation was filed with the Secretary of State of the State of Delaware on May 13, 2010. A Certificate of Amendment was filed with the Secretary of State of the State of Delaware on November 23, 2010.

**THIRD:** The existing Article I is hereby deleted in its entirety and replaced with the following:

The name of the Corporation (herein called the "Corporation") is Snapfinger, Inc.

**FOURTH:** The purpose of this Amendment No. 2 is to change the name of the Corporation to Snapfinger, Inc.

**FIFTH:** This amendment was duly adopted by the Board of Directors in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware and recommended to the stockholders of the Corporation for their adoption and approval.

**SIXTH:** In lieu of a meeting and vote of the stockholders, the stockholders of the Corporation approved the amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.
