**BILL OF SALE, ASSIGNMENT AND ASSUMPTION AGREEMENT**

THIS BILL OF SALE, ASSIGNMENT AND ASSUMPTION AGREEMENT (this "Agreement"), is dated as of January 1, 2008, and is by and between THE ABWA COMPANY, INC., a Missouri corporation (the "Seller") and ABWA MANAGEMENT, LLC, a Missouri limited liability company (the "Purchaser").

**RECITAL**

Seller and Purchaser are parties to an Asset Purchase Agreement, dated as of January 1, 2008 (the "Purchase Agreement"), providing for, among other things, the sale to Purchaser of the Purchased Assets on the terms and subject to the conditions set forth in the Purchase Agreement. This Agreement is the Bill of Sale and Assignment Agreement required under Section 6.3 of the Purchase Agreement. The Purchase Agreement is attached to this Agreement and is incorporated into this Agreement by this reference.

**AGREEMENT**

NOW, THEREFORE, intending to be legally bound, the parties agree as follows:

1. **Defined Terms.** Capitalized terms used in this Agreement without definition have the meanings ascribed to them in the Purchase Agreement (which meanings are incorporated into this Agreement by this reference).

2. **Conveyance of Purchased Assets.** Effective as of the date of this Agreement, Seller sells, assigns, transfers and delivers to Purchaser all of Seller's right, title and interest in and to the Purchased Assets.

3. **Acceptance by Purchaser; Assumption of Assumed Contracts.** Purchaser (i) acknowledges its acceptance of all right, title and interest in and to the Purchased Assets conveyed under Section 2 of this Agreement and (ii) assumes and agrees to discharge all liabilities and obligations arising on or after the date of this Agreement under each of the Assumed Contracts.

4. **Other Provisions.** The provisions of this Agreement bind and inure to the benefit of the parties and their respective successors and assigns. The headings in this Agreement are for convenience of reference only and will not control or affect the meaning or construction of any provisions of this Agreement. The parties may execute this Agreement contemporaneously in two or more counterparts (including facsimile and portable document format (.PDF) copies), any one of which need not contain the signatures of more than one party, but all the counterparts taken together will constitute one and the same Agreement. This Agreement will be construed in accordance with and governed by the internal laws of Missouri.
