**AMENDMENT NO. 1 TO  
SECOND AMENDED AND RESTATED PATENT,  
TRADEMARK AND LICENSE MORTGAGE -  
FERRARA PAN CANDY CO., INC.**

Amendment No. 1 to Second Amended and Restated Patent, Trademark and License Mortgage dated as of December 31, 2010, made by **FERRARA PAN CANDY CO., INC.** ("Mortgagor") in favor of COLE TAYLOR BANK, as Administrative Agent "hereinafter referred to as "Mortgagee") for **COLE TAYLOR BANK** ("CTB"), **BANK OF AMERICA, N.A., as successor by merger to LASALLE BUSINESS CREDIT, INC.** ("Bank of America") and any other person or entity which may at any time or from time to time in the future become a "Lender" pursuant to the Loan Agreement (defined below) (CTB, Bank of America and each such other person and entity shall be herein referred to individually as a "Lender" and collectively as the "Lenders").

**P R E A M B L E:**

Mortgagor gave to Mortgagee that certain Second Amended and Restated Patent, Trademark and License Mortgage dated as of November 11, 2009 (the "Mortgage"). Mortgagor, Ferrara Candy Co. Ltd. and Bellwood Building, LLC (individually, a "Borrower" and collectively, "Borrowers") have requested Administrative Agent and Lenders to modify Lenders' existing financing of Borrowers. Administrative Agent and Lenders have agreed to do so, so long as, among other things, Mortgagor executes and delivers to Mortgagee this Amendment.

NOW, THEREFORE, in consideration of the premises which are incorporated herein by this reference and constitute an integral part hereof and the execution and delivery of this Amendment, Mortgagor agrees as follows:

1. Exhibit B of the Mortgage is amended in the form of Exhibit B attached hereto and made a part hereof. All references in the Mortgage to "Trademark" and "Trademarks" shall be deemed to include, without limitation, all trademarks, trade names and service marks referenced on the attached Exhibit B.

2. All references to the "Mortgage" in the Mortgage shall mean the "Mortgage" as amended by this Amendment and as may be further amended and/or restated from time to time.

3. In all other respects, the Mortgage is hereby restated, reaffirmed and incorporated herein, the only amendments intended to be made thereto being those above set forth. Except as specifically set forth herein to the contrary, all terms defined in the Mortgage shall have the same meanings herein as therein.
