TRADEMARK SECURITY AGREEMENT SUPPLEMENT

WHEREAS, SGE IP Holdco, LLC, a Texas limited liability company (herein referred to as the "Licensor") having an address at 1950 N. Stemmons Freeway, Suite 3000M, Dallas, Texas 75207, has adopted, used, and is using the trademarks, tradenames, trade styles and service marks listed on the annexed Schedule A, which trademarks, tradenames, trade styles and service marks are registered in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, Licensor has granted to Stream Energy Pennsylvania, LLC, a Delaware limited liability company (herein referred to as the "Debtor"), having an address at 1500 Market St., 12th Floor, East Tower, Philadelphia, Pennsylvania 19102, a license to use the Trademarks pursuant to and in accordance with the terms of that certain Amended and Restated Trademark License Agreement dated as of March 30, 2011, between Licensor and Debtor (as amended or otherwise modified from time to time, the "Trademark License Agreement");

WHEREAS, SGE Energy Sourcing, LLC has entered into that certain ISDA Master Agreement dated as of March 30, 2011 with EDF Trading North America, LLC, a Texas limited liability company (together with its successors and assigns, "Secured Party"), and all schedules, annexes, confirmations, and transactions thereunder (as amended or otherwise modified from time to time, the "ISDA Master Agreement");

WHEREAS, in connection with the ISDA Master Agreement, Debtor has entered into a Security Agreement dated as of March 30, 2011 (as amended, supplemented, replaced, or otherwise modified from time to time, the "Security Agreement") in favor of Secured Party, pursuant to which Debtor has granted to Secured Party, a security interest in all present and future right, title, and interest of Debtor in and to the Trademark License Agreement, including Debtor's rights to use the Trademarks and all reissues, renewals, and extensions thereof thereunder and all proceeds thereof (the "Collateral"), to secure the payment, performance, and observance of the Secured Obligations (as defined in the ISDA Master Agreement);

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Debtor does hereby further confirm, and put on the public record, its grant to Secured Party of a security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

Debtor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the grant of, security interest in and mortgage on the Collateral made hereby are more fully set forth in the Security Agreement; the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
