THIS AGREEMENT is dated the 28TH day of MARCH 2011.

BETWEEN:

- (1) **HICHROM LIMITED** a company registered in England and Wales under company number 01873803 whose registered office is at 1 The Markham Centre, Station Road, Theale, Reading, Berks RG7 4PE, England (the "**Assignee**"); and
- (2) **BECKMAN COULTER, INC.**, a Delaware corporation with its principal place of business at 250 S. Kraemer Boulevard, Brea, California 92821, United States (the "**Assignor**").

WHEREAS:

- (A) The Assignor is the registered proprietor and beneficial owner of the registered trade mark set out in the Schedule hereto (the "**Trade Mark**").
- (B) Pursuant to an asset purchase agreement dated 19 October 2009 between the Assignor and the Assignee, the Assignor has agreed to assign all right, title and interest in the Trade Mark to the Assignee on the terms set out below.

IT IS AGREED as follows:

1. Assignment

In consideration of the sum of £1 (one pound) paid by the Assignee to the Assignor (receipt of which the Assignor hereby acknowledges), the Assignor hereby assigns with full title guarantee to the Assignee, absolutely, free from all liens, charges, security interests and/or encumbrances whatsoever, the Trade Mark and all and any rights in and to the Trade Mark, including any common law rights connected therewith, together with all the goodwill attaching to or associated with the Trade Mark.

2. Proceedings

- 2.1 This assignment shall include the right for the Assignee to bring all rights of action which have arisen or are arising or accrued in relation to the Trade Mark including, without limitation, the right to take proceedings and recover damages and obtain all other remedies in respect of past infringements of the Trade Mark or for passing off or for otherwise infringing the rights of the Assignor in the Trade Mark.
- 2.2 The Assignor agrees and undertakes to provide the Assignee (at its request) with all such assistance with any proceedings which may be brought by or against the Assignee against or by any third party in relation to the Trade Mark.

3. Further assurance

The Assignor agrees and undertakes to do or procure to be done all such further acts and things, and execute or procure the execution of all such other documents, as the Assignee may from time to time require in order to give the Assignee the full benefit of

this Agreement, whether in connection with any registration of title or other similar right or otherwise.

4. Governing law and jurisdiction


This Agreement shall be governed by and construed in accordance with the laws of England and the parties submit to the exclusive jurisdiction of the English courts.
