TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is made as of the 1st day of March, 2011 between TOM GREEN ("Green") and ACTION IMAGES, INC. ("Action Images"), 7148 N. Ridgeway Ave., Lincolnwood, Illinois 60712 (collectively "Assignors"), on the one hand, and MAJOR LEAGUE BASEBALL PROPERTIES, INC., 245 Park Avenue, New York, New York 10167 ("Assignee"), on the other hand.

WHEREAS, Green is the owner of United States Registration No. 3,419,253 (the "Registration") for the trademark SPRING TRAINING (the "Green's SPRING TRAINING Mark") for "T-shirts" in International Class 25 and Green has carried out his business activities concerning Green's SPRING TRAINING Mark through Action Images, which is owned and controlled by Green; and

WHEREAS, Green is the owner of United States Application Serial No. 77/757,875 for the mark ALLSTAR ("Green's ALLSTAR Mark") for "bakery goods; cookies" in International Class 30 and Green has carried out his business activities concerning Green's ALLSTAR Mark through Action Images, which is owned and controlled by Green; and


WHEREAS, Assignors desire to transfer all of their rights, title and interest in Green's SPRING TRAINING Mark and Green's ALLSTAR Mark (collectively, the "Marks") together with the goodwill of the business symbolized thereby, and the Registration, to Assignee, and Assignee desires to accept said transfer;

NOW, THEREFORE, for the sum of \$1.00 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, as of the date indicated above, Assignors assign and transfer to Assignee, its successors and assigns, absolutely and forever, all of Assignors' rights, title and interest in and to the Marks, whether statutory or at common law together with the goodwill of the business symbolized by the Marks, and all causes of action for any and all past infringements of the rights so assigned occurring before or after the date of this Assignment and the right to collect and retain the proceeds therefrom, and Green assigns and transfers to Assignee, its successors and assigns, absolutely and forever all of Green's rights, title and interest in and to the Registration, and Assignors agree to provide Assignee with any documentation, specimens, use evidence, and/or other materials as may be requested from time to time by Assignee to support the recordation of this Assignment and/or maintenance of the Registration with the United States Patent and Trademark Office or otherwise to enforce Assignee's rights in the Marks.
