KINNEY**, appearing herein in his capacity as Trustee of the Leon Galatoire Trust (TIN 72-6116570), by virtue of a trust instrument executed on January 6<sup>th</sup>, 1986, recorded in the conveyance records of Orleans Parish, Louisiana as Instrument # 1986011170, NA #635878, and order appointing Henry W. Kinney successor trustee rendered on January 17, 2006, recorded at Instrument #319588, NA #06-07575 in the conveyance records of Orleans Parish, Louisiana.

**LEON R. GALATOIRE**, a person of the full age of majority who lives and resides in the Parish of St. Tammany, State of Louisiana, who declared unto me, Notary Public, that he has been married but once and then unto Lisa Pique Galatoire with whom he is currently living and residing.

**WHEREAS**, On January 6<sup>th</sup>, 1986, Leon Galatoire established the "Leon Galatoire Trust" (hereinafter the "Trust"). A copy of the Trust has been attached hereto as Exhibit "A."

**WHEREAS**, the Trust Instrument named Leon Galatoire as Principal and Income Beneficiary of the Trust (hereinafter the "Beneficiary");

**WHEREAS**, the Trust Instrument (hereinafter the "Instrument"), recorded in the Orleans Parish Conveyance Office under CIN #1986011170, NA #635878, transferred Leon Galatoire's interest in the property located at 209 Bourbon Street in New Orleans, Louisiana, as more fully described in the Instrument, to the Trust;

**WHEREAS**, Henry W. Kinney was appointed Successor Trustee of the Trust by an Order dated January 17, 2006 in the Civil District Court for the Parish of Orleans, Proceeding # 06-437. A copy of the Order is attached hereto as Exhibit "B." The Order was recorded in the Conveyance Office of Orleans Parish, Instrument #319588, NA #06-07575;

**WHEREAS**, the Instrument provides that the Trustee shall have the authority to terminate the trust in the event in the sole opinion of the trustee the purpose of the trust is no longer necessary and the interest of the beneficiary would be better served by its termination;

**WHEREAS**, Leon Galatoire has requested that Henry W. Kinney dissolve the Trust immediately following the purchase of substantially all of the assets of Galatoire's Restaurant, LLC and an undivided seventy-five percent interest in the immovable property located at 209 Bourbon Street in New Orleans, Louisiana by Duane Attaway, Michele Galatoire, and Henry W. Kinney as the Trustee of the Trust; and

**WHEREAS**, it is the opinion of the Henry W. Kinney that the purpose of the Trust is no longer necessary and the interest of Leon Galatoire would be better served by its termination;

**NOW THEREFORE**, in consideration of the foregoing, the Trust has been terminated subsequent to the purchase of substantially all of the assets of Galatoire's Restaurant, LLC and an undivided seventy-five percent interest in the immovable property located at 209 Bourbon Street

in New Orleans, Louisiana by Duane Attaway, Michele Galatoire, and Henry W. Kinney as the Trustee of the Trust, and the principal of the Trust is hereby distributed to and accepted by the Beneficiary, Leon Galatoire, which includes but not limited to the following described property:

A CERTAIN LOT OR PORTION OF GROUND, together with all the buildings and improvements thereon and all of the rights, ways, privileges and servitudes and appurtenances thereunto belonging or in anywise appertaining, situated in the Second District of the City of New Orleans, in SQUARE NO. 68, bounded by Bourbon, Iberville, Bienville and Dauphine Streets, which said lot begins at a point fifty-eight (58') feet nine (9") inches from the corner of Iberville and Bourbon Streets and has a frontage on Bourbon Street of Thirty-two (32') feet, two (2") inches and four (4") lines, with a depth of one hundred twenty-eight (128') feet between equal and parallel lines, according to a survey made by C. Uncaf Lewis, Deputy City Surveyor, dated May 23, 1919.

AND

A CERTAIN LOT OR PORTION OF GROUND, together with all the buildings and improvements thereon and all of the rights, ways, privileges, servitudes and appurtenances thereunto belonging or in anywise appertaining, situated in the Second District of the City of New Orleans in SQUARE NO. 68 bounded by Bourbon, Iberville, Bienville and Dauphine Streets designated as Lot No. 28 on a blue print of survey by Gilbert and Kelly, Surveyors, dated November 29, 1943, annexed to an act passed before John F. Koningh, Notary Public, dated January 10, 1944, according to which said lot begins at a distance of one hundred one (101') feet, five (5") inches and four (4") lines from the corner of Iberville and Bourbon Streets and measures thence twenty-six (26') feet front on Iberville Street by a depth of fifty-nine (59') feet between equal and parallel lines.






