**TRADEMARK AND PATENT SECURITY AGREEMENT**

This Trademark and Patent Security Agreement ("Agreement") is made this 25<sup>th</sup> day of February, 2011, by and between Peak Wellness, Inc., a Connecticut corporation doing business as Peak Wellness Biopharma ("Grantee"), and Atlas Acquisition Corp., a Nevada corporation ("Grantor").

WHEREAS, Grantor is the owner of the U.S. trademark application and patent application listed on the attached Schedule A (collectively the "Mark and Application");

WHEREAS, Grantee has extended a loan to Grantor pursuant to the terms and conditions of that certain Promissory Note dated the date hereof ("Note") made by Grantor in favor of Grantee;

WHEREAS, under a Security Agreement dated the date hereof ("Security Agreement") between Grantor and Grantee, Grantor has granted to Grantee a security interest in certain of its assets (including the Mark and Application and the goodwill associated therewith) to secure the performance of the obligations of Grantor under the Note; and

WHEREAS, Grantor and Grantee by this instrument seek to confirm and make a record of the grant of a security interest in the Mark and Application and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Grantor does hereby acknowledge that it has granted to Grantee a security interest in all of Grantor's right, title and interest in, to, and under the Mark and Application and the goodwill associated therewith. Grantor also acknowledges and confirms that the rights and remedies of Grantee with respect to the security interests in the Mark granted hereby are more fully set forth in the Note and the Security Agreement, the terms and provisions of which are incorporated herein by reference. Grantor and Grantee hereby acknowledge and agree that the security interest in the Mark and Application (i) shall be terminated in accordance with the terms of the Security Agreement and (ii) is not to be construed as an assignment of any Mark or Application, or any subsequently issued registration.




