**ASSIGNMENT OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

("Borrower"), the guarantors of Borrower and Allied Capital Corporation (the "Security and Pledge Agreement"); and (ii) the security interests and liens granted by Borrower to ASSIGNOR in the intellectual property collateral including, without limitation, the trademark and copyright registrations identified in Exhibit A attached hereto and all contract rights and all patents, trademarks, service marks, trade names (including any goodwill of the business in which the marks are used and symbolized by the marks) and copyrights and any applications, renewals and extensions for any of the foregoing, all rights and causes of action to recover past, present or future damages, royalties, fees, profits or other relief, including but not limited to, equitable and injunctive relief ensuing from infringement thereof, and the priority of the security interests evidenced by or related to the Security and Pledge Agreement.

This Assignment is given pursuant to those certain two Purchase and Sale Agreements For Distressed Trades each dated as of May 27, 2011 between the ASSIGNOR and ASSIGNEE and no representation, warranty or covenant is made by, and there is no recourse to, ASSIGNOR pursuant to this Assignment except as may be set forth in said Purchase Agreements. THIS ASSIGNMENT SHALL BE GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
