**FIRST:** The name of the corporation is MD Acquisition Sub, Inc. (the "Corporation").

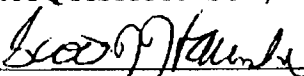
**SECOND:** Paragraph 1 of the Certificate of Incorporation of the Corporation is hereby amended and restated in its entirety as follows:
