FULL RELEASE AND RECONVEYANCE
(in Security Interests in GroupEx Financial Corporation Trademarks)

THIS FULL RELEASE AND RECONVEYANCE (this "Agreement"), dated as of June 9, 2011, is granted by Bank of America, N.A., as Administrative Agent ("Agent") for certain Lenders (defined below), in favor of GroupEx Financial Corporation, a Delaware corporation ("Grantor").

RECITALS

A. Reference is made to that certain Guarantee and Collateral Agreement dated as of November 20, 2007 among Grantor, Agent, certain banks and other financial institutions ("Lenders") and certain other parties thereto (as amended, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement"). Capitalized terms used but not defined herein shall have the same meanings set forth in the Guarantee and Collateral Agreement.

B. Pursuant to the Guarantee and Collateral Agreement, Grantor granted to Agent, for the benefit of Lenders, a security interest in, among other things, all of Grantor's Intellectual Property, including the Trademarks set forth on Schedule A attached hereto.

C. Agent acted to perfect its security interest in the Trademarks by filing the Grant of Security Interest in Trademark Rights in the United States Patent and Trademark Office ("USPTO"), recorded on February 14, 2008 at Reel/Frame 003719/0543 (the "Grant of Security Interest").

D. Agent has agreed to release its security interest in Grantor's Intellectual Property, including the Trademarks set forth on Schedule A.

NOW, THEREFORE, in consideration of mutual promises and covenants, Agent hereby agrees as follows:


1. Agent hereby releases its security interest granted by Grantor to Agent, on behalf of Lenders, in Grantor's Intellectual Property, including the Trademarks identified on Schedule A and all goodwill and common law rights associated therewith, unconditionally and irrevocably terminates the Grant of Security Interest recorded in the USPTO, including any right to assignment of the Trademark set forth on Schedule A, and hereby assigns to Grantor all of Agent's rights to and interest in the Trademarks.

2. Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interests contemplated hereby.

3. This Agreement has been executed and delivered by Agent for the purpose of recording the release and reconveyance of security interest herein with the USPTO.



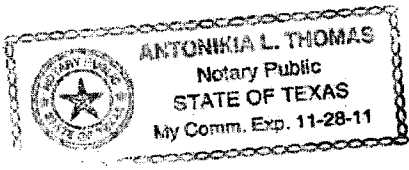
