## Intellectual Property Assignment Agreement

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this “**IP Assignment**”), dated as of March 17, 2011 (the “**Effective Date**”), is made by and between Skinny Girl Cocktails LLC, a Delaware limited liability company (“**Seller**”) and Jim Beam Brands Co., a Delaware corporation (“**Buyer**”), the purchaser of certain assets of Seller pursuant to an Asset Purchase Agreement, dated as of the Effective Date (the “**Purchase Agreement**”).

Under the terms of the Purchase Agreement, Seller has conveyed, transferred and assigned to Buyer, among other assets, certain intellectual property of Seller, and has agreed to execute and deliver this IP Assignment, for recording with international, national, federal and state government authorities including, but not limited to, with respect to individual registered trademarks and copyrights, and applications for the foregoing, the U.S. Patent and Trademark Office and the U.S. Copyright Office.

By virtue of the Purchase Agreement, Buyer is the successor to the ongoing and existing portion of the business of Seller to which the Trademarks (as defined below) assigned herein pertain.

NOW THEREFORE, for good and valuable consideration, and in further consideration of the mutual covenants and agreements contained in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, the Seller agrees as follows:

1. Assignment. Seller hereby conveys, transfers and assigns to Buyer all of Seller’s right, title and interest in and to the following (the “**IP Assets**”):
  - (a) the trademark registrations and applications set forth in Schedule 1 hereto, solely to the extent they cover International Class 33 (or its equivalent Class, or equivalent goods to the extent the country does not use Class designations), together with the goodwill symbolized thereby, and all issuances, extensions and renewals thereof (the “**Trademarks**”);
  - (b) the copyright registrations, applications for registration and exclusive copyright licenses set forth in Schedule 2 hereto and all issuances, extensions and renewals thereof (the “**Copyrights**”);
  - (c) the domain names and registrations thereof set forth in Schedule 3 hereto and all issuances, extensions and renewals thereof (the “**Domain Names**”);

- (d) all rights of any kind whatsoever of Seller accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;
  - (e) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
  - (f) any and all claims, with respect to any of the foregoing, for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
2. Recordation. Seller authorizes the Commissioner for Trademarks and the Register of Copyrights and any other international, national, federal and state government officials to record and register this IP Assignment upon request by Buyer.
  3. Terms of the Purchase Agreement. This Agreement is executed and delivered pursuant to the Purchase Agreement. Nothing in this Agreement, express or implied, is intended or shall be construed to modify, expand or limit in any way the terms of the Purchase Agreement, including, but not limited to, the representations, warranties, covenants, agreements and indemnities relating to the Purchased Assets are incorporated herein by this reference. The parties hereto acknowledge and agree that the representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. To the extent that any provision of this Agreement conflicts or is inconsistent with the terms of the Purchase Agreement, the terms of the Purchase Agreement shall govern. Seller does not make any additional representations or warranties with respect to the Purchased Assets to Buyer in addition to those made under the Purchase Agreement pursuant to this Agreement.
  4. Counterparts. This IP Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this IP Assignment delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this IP Assignment.
  5. Governing Law. This IP Assignment shall be governed by the laws of the State of New York.

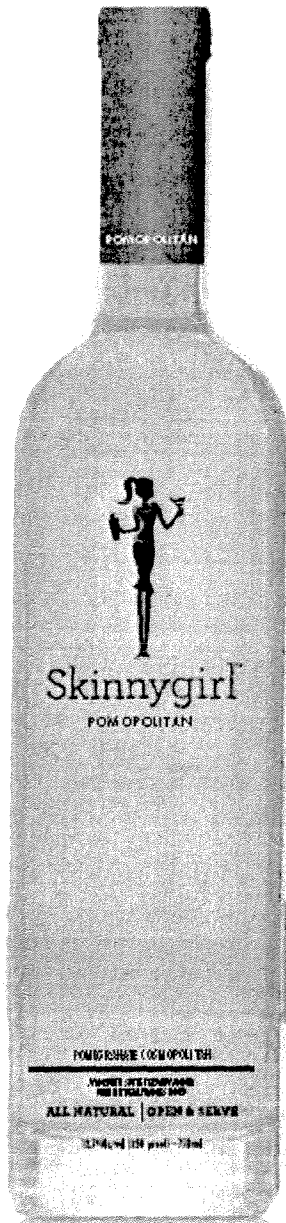
