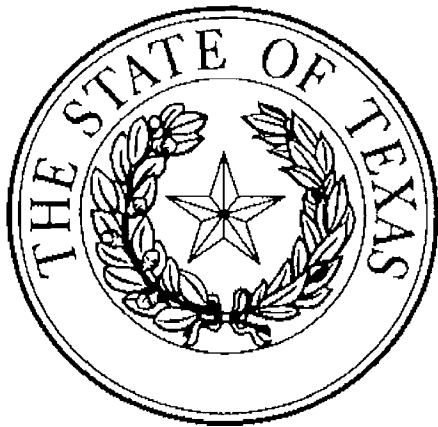

ENGINEERING PHYSICS SOFTWARE, INC. (the "Corporation"), a for-profit corporation organized and existing under the laws of the State of Texas, does hereby certify as follows:

FIRST: The present name of the Corporation is ENGINEERING PHYSICS SOFTWARE, INC. The original Articles of Incorporation of the Corporation was filed with the Secretary of State of the State of Texas pursuant to the Texas Business Corporation Act (the "Act") on June 20, 1988. The original Articles of Incorporation were amended by the Articles of Amendment filed with the Secretary of State of the State of Texas pursuant to the Act on May 8, 2000.

SECOND: This Certificate of Amendment was approved by a unanimous written consent of all of the members of the Board of Directors and the shareholders of the Corporation as of May 17, 2010 in accordance with the Business Organization Code of the State of Texas (the "Code") and organizational documents of the Corporation, as previously amended.

THIRD: ARTICLE I of the Articles of Incorporation, as previously amended, is further amended by deleting existing Article I in its entirety and replacing it as follows:

"ARTICLE I

The name of the Corporation is INTERGRAPH CADWORX &
ANALYSIS SOLUTIONS, INC."

FOURTH: As of the date hereof, the Corporation had 20,000 shares of common stock outstanding, all of which voted in favor of the amendment by unanimous written consent as of May 17, 2010.

This Certificate of Amendment is being filed for the purpose of effecting such amendment in accordance with the requirements of the Code.
