Assignment

- (2) The Assignor covenants to execute all such documents, forms and authorisations and depose to or swear any declaration or oath as may be required by the United Kingdom Intellectual Property Office, the Community Trade Mark Office and the United States Patent and Trademark Office for absolutely vesting the benefit of the Trade Marks in favour of the Assignee.
