AND, said Assignor hereby covenants that it has full right to convey the entire interest herein assigned.

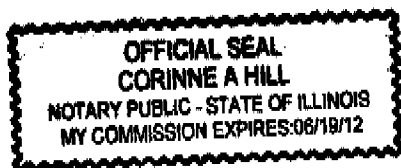
