**CERTIFICATE OF AMENDMENT  
of the  
CERTIFICATE OF INCORPORATION  
of  
CLIMAX MANUFACTURING COMPANY**

**Under Section 805 of the Business Corporation Law**

FIRST: The name of the Corporation is Climax Manufacturing Company.

SECOND: The Certificate of Incorporation of the Corporation was filed by the Department of State on December 11, 2001 under the name of Climax Manufacturing Acquisitions, Inc. A Certificate of Merger was filed with the Department of State on December 21, 2001 and the Company's name was changed to Climax Manufacturing Company.

THIRD: The Certificate of Incorporation of the Corporation is hereby amended to effect the amendments specified below, which are authorized by the Business Corporation Law:

A. Paragraph "1" of the Certificate of Incorporation is hereby amended to change the name of the Corporation, so that said Paragraph "1" shall provide in its entirety as follows:

"1. The name of the Corporation is Climax Paperboard, Inc."

FOURTH: The Certificate of Amendment of the Certificate of Incorporation effected hereby was authorized by the unanimous written consent of the Board of Directors followed by the written consent of the holder of all of the outstanding shares entitled to vote thereon.
