**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

TERMINATION AND RELEASE, dated as of July 11, 2011, from JPMORGAN CHASE BANK, N.A., a national banking association (as successor-in-interest to THE FIRST NATIONAL BANK OF CHICAGO), as Secured Party (the "Secured Party") for certain financial institutions (the "Lenders"), to RAWLINGS SPORTING GOODS COMPANY, INC., a Delaware corporation (the "Debtor").

WITNESSETH:

WHEREAS, pursuant to the Intellectual Property Assignment of Security Interest, dated as of July 14, 1999, made by the Debtor in favor of the Secured Party (the "Security Agreement"), a security interest (the "Security Interest") was granted by the Debtor to the Secured Party in certain Collateral (as defined in the Security Agreement);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on July 20, 1999 at Reel 2033/Frame 0231;

WHEREAS, the Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on July 20, 1999 at Reel 010078/Frame 0001; and

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby states as follows:

1. Definitions: The term "Collateral," as used herein, shall have the meaning provided by reference in the Security Agreement and shall include all of the Debtor's right, title and interest of every kind and nature as of the date hereof in the Copyrights (including, without limitation, those items listed on Schedule A hereto), the Trademarks (including, without limitation, those items listed on Schedule B hereto), the Licenses (including, without limitation, those items listed on Schedule C hereto), and the Patents (including, without limitation, those items listed on Schedule D hereto).

2. Release of Security Interest: The Secured Party hereby terminates, releases and discharges its Security Interest in the Collateral, and any right, title or interest of the Secured Party in such Collateral shall hereby cease and become void.

3. Further Assurances: The Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

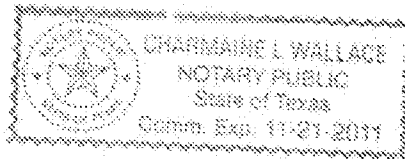
