Change of Name

Applicant MedTech Holdings, Inc. (“Applicant”), by and through its counsel, respectfully requests that the United States Patent and Trademark Office (“PTO”) change the name listed as the owner in the application from “MedTech Group Holdings, Inc.” to “MedTech Holdings, Inc.” Applicant’s requested amendment is not meant to designate one legal entity for another, but rather to correct a mistake made on the part of Applicant.

Mistakes made in an application may be amended as long as the amendment is not to designate another entity as the applicant. TMEP 803.06; 1201.02(c). *U.S. Pioneer Elecs. Corp. v. Evans Mktg., Inc.*, 183 USPQ 613 (Comm’r Pats. 1974).

Applicant is not substituting one party for another, but rather correcting a misidentification of the Applicant’s legal name. “MedTech Group Holdings, Inc.” does not and has never existed as a legal entity. Instead, MedTech Holdings, Inc. is the proper legal entity and is registered as a corporation in Delaware. Applicant did not intend to deceive when it listed MedTech Group Holdings, Inc. as the owner in its application. In addition, it is only a slight variation of the correct legal entity name, MedTech Holdings, Inc. *U.S. Pioneer Elecs. Corp* 183 USPQ 613 at 614. (Comm’r Pats. 1974) (holding that the name EVANS MARKETING COMPANY, INC was only a slight variation of EVANS MARKETING INC. and that the information given in the original application was misinformation without an intent to deceive.)

In light of the foregoing, Applicant respectfully requests the PTO change the name of the owner in its application to MedTech Holdings, Inc.
