RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (this "Release"), dated as of July 25, 2011, is made by Bank of America, N.A., acting as administrative agent (the "Administrative Agent") for the Secured Parties (as defined in the Security Agreement described below).

WHEREAS, the Administrative Agent and L-1 Identity Solutions Inc., a Delaware corporation (the "Grantor") are parties to that certain Second Amended and Restated Security Agreement, dated as of August 5, 2008 (as amended, modified, extended or restated from time to time, the "Security Agreement"; terms used herein and not otherwise defined herein shall have the meanings ascribed to such terms in the Security Agreement) pursuant to which (i) Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in certain trademarks, trademark registrations and trademark applications listed on Schedule A attached hereto (the "Trademark Collateral") and (ii) a Notice of Grant of Security Interest in Trademarks was recorded with the United States Patent and Trademark Office on August 13, 2008 at Reel 3834, Frame 0826 (the "Trademark Notice"); and

WHEREAS, Grantor has requested that the Administrative Agent release its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Administrative Agent hereby releases all of its security interests in, without any representation, warranty, recourse or undertaking by the Administrative Agent, all of its right, title and interest, if any, in and to:

(i) the Trademark Collateral, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and


(ii) all proceeds of the foregoing, including without limitation any claim by Grantor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration or trademark application included in the Trademark Collateral, in each case any right to sue and collect for said damages.

This Release shall be governed by, and construed by and interpreted in accordance with, the law of the State of New York.
