TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") is entered into as of 7-16, 2011, by and among William Vitanyi ("Assignor"), and Build-A-Bear Retail Management, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor is the owner of the entire right, title and interest in and to the trademark BUILD A BOOK for book publishing and U.S. App. Serial No. 77/751,066 (the "Mark");

WHEREAS, Assignee has agreed to purchase from Assignor fourteen (14) cases of the book "The Official Guide to Office Wellness" for the sum of \$9000;

WHEREAS, Assignor wishes to assign the entire rights, title and interest in and to the Mark, including U.S. App. Serial No. 77/751,066 and the goodwill associated with such Mark to Assignee and Assignee desires to assume such mark and the goodwill of the business related thereto.


NOW, THEREFORE, in consideration of one (1) dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby sells, assigns, transfers and sets over unto Assignee all of Assignor's right, title and interest in and to the Mark and U.S. App. Serial No. 77/751,066, together with the goodwill of the business associated therewith, and all causes of action, past, present and future for infringement of the Mark.

2. Assignor further covenants and agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect the title to the Mark in Assignee, its successors and assigns, and that it will, at any time upon request, communicate and provide to Assignee, its successors and assigns, such facts and documents relating to the Mark or the history thereof as may be known to it.


